#### **FEEDBACK ANALYSIS (STUDENTS)-2016-17**

Feedback of students was sought for the academic year 2016-17 from students of LL.B. final year (3 Yrs) course and BSL final year (5 Yrs) course at the end of academic year after declaration of results. Students were randomly selected for feedback collection. Feedback was sought on administration, academics, library facilities, infrastructural facilities and sports facilities.

##### **Feedback about administration:**

To the question about difficulty in administration, 50% of students of BSL answered that they faced difficulty in administration while 50% said that they did not face difficulty. Out of the 50% who suffered difficulty, 50% said that they faced difficulty in examination section while 50% at scholarship section. None of the student faced difficulty at the admission section. 75% percent students were happy with administration while 25% were not so.

Same results were revealed from LL.B. students. 50% students faced difficulty in administration, of these 50%, half of the students faced difficulty at the examination section and 50% at the scholarship section. Similarly, students of LL.B. also did not face difficulty at the admission section. 75% students were happy with administration while 25% were not happy with it.

##### **Feedback about Academics:**

Feedback was sought about curricula, teaching of faculty and teaching modes and modalities. As regards students of BSL, 75% students were happy with the existing curricula while 25% did not reply. 100% students were satisfied with teaching of the faculty and the modes and modalities adopted by them.

With respect to students of LL.B., 75% students were satisfied with existing curricula and 25% were partly happy. 100% students of LL.B. were satisfied with teaching of the faculty and their modes and modalities.

##### **Feedback about library:**

Student's feedback was sought on library and parameters were collection of books, computer lab, e-facilities and library infrastructure. 100% students of both the streams, LL.B. and BSL were happy with the collection of books in the library. Similarly 75% of students of both the streams found satisfied with the library infrastructure and 25% were not satisfied. As

regards computer lab and e-facilities, 25% students from BSL were found to be happy, 50% partly happy and 25% were not happy with it. As regards students of LL.B. 75% were happy while 25% were partly happy with it.

#### **Feedback about infrastructure:**

Under this head, students were asked to rate the class rooms and seating arrangements, ICT Smart Class rooms and overall infrastructure of the College. As regards BSL, 75% students rated the classrooms and seating arrangements as average and 25% as good. 25% rated the smart class rooms as very good and 75% as good. With respect to overall infrastructure, none of the students reply to the question. As regards students of LL.B., 50% students rated the class rooms and seating arrangements as very good while 25% as good and 25% as average. 25% students rated the ICT smart class rooms as very good and 75% as good. These students also did not give any rating about overall infrastructural facilities.

#### **Feedback about Sports facilities:**

Presently the College has indoor court for badminton, table tennis, flood light volley ball court, well equipped gym for the students. Students were asked about participation in sports, standard of sports facilities and need for its enhancement. 75% students of BSL said that they participate in sports while 25% did not. 25% students found the sports facilities as very good and 75% as good. However, all the participants expressed that there is need to enhance sports facilities.

As regards students of LL.B. 50% said that they participate in sports and 50% did not. 50% students rated the sports facilities as good and 50% rated as average. Again all the participants opined need of enhancement in sports facilities.

Lastly, students were asked to give opinion about their expectations from the College. 25% students of BSL gave suggestions while 75% did not. The participants expected cooperation from the administration and improvement in sports facilities while did not express expectations from teaching and library. As regards students of LL.B., again 25% participants expected cooperation from administration but did not express expectations from teaching, library or sports department.
